Contract for Foam Rox Mobile Foam Event

This Agreement and Contract specifies the services of Fun Rox, LLC, d/b/a Foam Rox to provide foam for the event specified below. This Agreement and Contract is to be signed along with the Release Agreement also to be supplied by Foam Rox. The Agreement and Contract for the services described below is made this date, between the undersigned "Client" and the undersigned service provider, Foam Rox.

Foam Rox will provide the following for your event – foam machine and supplies, barrier fencing to delineate the foam play area and the operator for the equipment.

Client agrees to provide a 110V (20amp) electrical outlet with an earth grounding receptacle and a Ground Fault Circuit Interrupt (GFCI) and a water supply (Please Note - water softeners act like a de-foamer and will not be conducive to good foam production).

The setup should be such that the electrical and water supply will not be interfered with by children or others.

Client further agrees that a specified representative will be present to maintain order and all safety precautions. Client also understands that foam, by nature is wet, and can cause any surface it comes into contact with to be more slippery than when dry. Client understands that Foam Rox will maintain foam at a level that is age appropriate for the smallest participate and that Foam Rox may specify a limit on the number of participants at any one time, should the need arise for safety purposes.

Client agrees that all care will be taken with the Slip 'N Slide to insure that it is not abused and is returned in the same condition as when it arrives. Client further agrees to incur any and all repair costs to the Slide in the event it is damaged due to abuse.

Foam Rox Rates:

- **Up to 1 hour of foam with 20' x 20' inflatable Foam Pit - \$340.00**
- **For each additional hour and up to 50 gallons of solution - \$135.00**
- **For events where Foam Rox needs to supply padding for the foam pit, please add \$40 fee.**
- **For events over 20 miles from I-10 Katy Freeway/Beltway 8, there is a \$25 service charge, plus \$1.00 per mile charge r/t**
